ENGAGEMENT OF DOCTORS AND PARA MEDICAL STAFF ON CONTRACT BASIS

In view of the exigencies related with the COVID-19 Pandemic, Southern Railway, Chennai Division has decided to engage Full Time Medical Practitioners and Para Medical Personnel (Nursing Staff) immediately for a period of maximum six months at DRH/AJJ and Railway Health Units at NGO/MAS, JTJ CGL, TBM, MS, TNPM and AVD to manage fever clinics on contract basis.

II. Age, Criteria, Required Educational Qualification & Experience.

III. Selection Process

Interview will be conducted for selection of suitable candidates for contract Medical Practitioners & Staff Nurses through teleconferencing Online / Phone.

IV. Medical Examination:

The candidates shall undergo a medical examination, before the contract is entered into for fitness to perform the work awarded to him/her. At the time of entering into contract, the CMP shall produce certificate of his/her character and antecedents from two gazetted officers of the central/State Government.

V. Terms and Conditions:

1. The engagement of the contract Medical Practitioner and Contract Staff Nurses would be on the fulltime contract basis for a period of maximum six months from the date of engagement (if the scheme of engagement on contract basis is not extended). The service rendered during the contract is an arrangement for meeting

up the requirement of the pandemic situation and it will not confer any right for automatic regularization/absorption in Southern Railway in any circumstances.

- 2. The services as Contract Medical Practitioner or Contract Staff Nurse on contract basis is a stop gap arrangement and will not have any bearing in respect of consideration of their period of service in case of regular selection through RRB or UPSC.
- 3. Full time Contract Staff who enters into contract with the Railways will not have any claim or right for his/her regularization or absorption Railway service.
- 4. During the validity of contracts, the Railway Administration will be at liberty to terminate the contract at any time during the contract period for administrative reasons whatsoever. The contract shall also be terminated forthwith if the work of the Contract Staff is found to be unsatisfactory and the full time Contract Staff is found to be physically or mentally invalid or incapacitated.
- 5. Candidates proposed to be engaged on contract should be fit medically.
 - 6. They should attend COVID-19 patients and related duties.
- 7. The detailed instructions with regard to the duties shall be given to the candidates who are selected, along with the offer of engagement.
- 8. The candidates on contract are required to follow the dress code as per administrative requirement at their own cost.
- 9. The contract will be ceased on completion of the period of 6 months automatically.
- 10. The selected candidate will be paid remuneration as noted in Para-I mentioned above and the candidates cannot claim any additional remuneration allowance or other benefits during the course of contract period.
- 11. In the event of unauthorised absence of Contract Medical Practitioner / Contract Staff Nurse from duty or absence from duty for a period exceeding the period stipulated in the contract, there shall be proportionate deduction from remuneration.
- 12. No private practice or any other employment will be permitted during the contract period.

- 13. The candidates are personally responsible for payment of professional tax, income tax and other duties/taxes leviable by the State/Central Governments from time to time.
- 14. The selection on contract basis to the above posts is a temporary measure owing to the pandemic of COVID-19. Railway administration reserves the right to reduce the number of vacancies notified or the number of persons engaged at any time considering the prevailing conditions and or based on the directions of Central/State Governments.
 - 15. Engaged Doctors and Para Medical staff on contract basis are not entitled to any benefits like PF, Pensions, Gratuity, Non-Practicing Allowance, Medical facilities seniority, promotion etc or any other benefits available to the Railway servants appointed on regular basis.

Candidates who fulfill the above terms and conditions and having requisite qualification may submit their application online through the following links on or before 13.05.2021, 17.00 hrs. Based on the number of applications received, screening would be done and shortlisted candidates will be informed about the Date and Time of tele conferencing Interview.

The shortlisted candidates have to produce the following original certificates at the time of entering into contract.

- a. Date of birth certificate or SSLC / SSE Board Certificate.
- b. All Education certificates (eg SSLC/SSC, HSC, Degree, PG, etc)
- c. If working NOC from the current employer
- d. Experience certificate if any. (The experience certificate should be on the letter head of the hospital/clinic with clear signature & seal/ Stamp of the issuing authority).
- e. Academic/Educational Qualification must be from a recognized Institution/Board (MarkSheet and Certificate).
- f. 6 nos of passport size photographs, along with ID

proof (at the time of appointment).

Candidates who fulfill the above terms and conditions and having requisite qualification may register their details accordingly.
