Each U-H&WC in the 500 locations will have the following Human Resources:-

ORDER:

In the circumstances reported by the Director of Public Health and Preventive Medicine in his letter eight read above, the Government have worked out a new scoring criteria to assess the applications for the selection of National Health Mission contractual Mid-Level Healthcare Provider attached to the Health and Wellness Centres sanctioned in Government Order first and second read above and vacant Staff Nurse posts in Director of Medical Education / Director of Medical and Rural Health Services / Director of Public Health and Preventive Medicine(Both Rural and Urban) Institutions, temporarily through District Health Society. These guidelines are issued by superseding the orders issued in annexure II to G.O(Ms).No.531, Health and Family Welfare Department, Dated 25.11.2022 and orders accordingly as detailed below:
