ADVERTISEMENT FOR FILLING UP OF THE POSTS OF CHAIRPERSON OF STATE FOOD COMMISSION, TAMIL NADU

Applications are invited for appointment to the posts of a Chairperson in the Tamil Nadu State Food Commission, set up by Government of Tamil Nadu under the provisions of the Tamil Nadu Food Security Rules, 2017. The Chairperson of the State Food Commission are to perform such duties and functions and exercise such powers as prescribed under the Tamil Nadu Food Security Rules, 2017. The Head Quarters of the Commission shall be at Chennai.

2. Eligibility Criteria:

(iii) The Chairperson shall be appointed from amongst persons:-

- (g) Who have been members of the All India Services or any other civil services of the Union or State or holding a civil post under the Union or State, having knowledge and experience in matters relating to food security, policy making and administration in the field of agriculture, civil supplies, nutrition, health or in any allied field; or
- (h) of eminence in public life with wide knowledge and experience in agriculture, law, human rights, social service, management, nutrition, health, food policy and public administration; or
- (i) who have a proven record of work relating to the improvement of the food and nutrition rights of the poor.

3. Age limit and tenure:


1. The Chairperson of the State Food Commission shall hold office for a term not exceeding five years from the date on which he/she enters upon the office, and shall be eligible for re-appointment, provided that no persons shall hold office as Chairperson/Members after he/she has attained the age of 65 years. The Chairperson shall not concomitantly hold any other office.


3. The applicants are advised to go through the provisions of the Tamil Nadu Food Security Rules, 2017 and satisfy themselves about their eligibility and other conditions for being appointed as Chairperson.

The candidates who fulfill the eligibility criteria given above may send their applications in the prescribed Proforma hosted on Department's website-www.tnpds.gov.in, together with the self-attested copies of supporting documents addressed to "**Director, Civil Supplies and Consumer Protection Department,Chepauk,Chennai-5**" by post or in person, on or before **21. 03.2025**

The candidates working in Government/PSUs/Autonomous Bodies etc. must send their application through proper channel along with self-attested copies of the supporting documents.

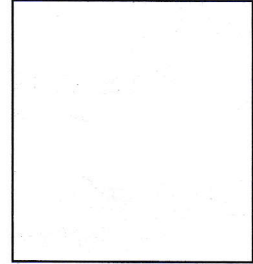

- (2) The Chairperson shall not be entitled to any pension for their service rendered in the Commission.
- (3) The Chairperson of the Commission may, by notice in writing under his hand addressed to the State Government, resign from the office of the , as the case may be, at any time.
- (4) A casual vacancy of Chairperson shall be filled up as soon may be, the appointment of another member by this State Government from the panel of names recommended by the Selection Committee referred to in Rule 16. The person so appointed shall hold office for the remaining period of the tenure of the member in whose place he is appointed.
